

Privacy Statement of Green Mini host BV

Through its hosting company website, www.greenmini.nl, www.greenminihost.com and www.greenmini.host, we will process privacy sensitive or personal data. Green Mini host BV values the privacy of its customers and observes due care in processing and protecting personal data.

During the processing we conform to the requirements of the applicable data protection legislation. This means we:

Google Analytics

We have a self hosted Matomo Analytics tool to track visitors on our website and to get reports about how visitors use the website. We don't use information obtained by Matomo for other services, and we anonymize the IP-addresses of visitors.

Security

We take security measures to reduce misuse of and unauthorised access to personal data. We take, amongst others, the following measures in particular:

- Access to personal data requires the use of a user name, password and 2FA token
- We take physical measures to protect access to the systems in which the personal data is stored
- We make use of secure connections (TLS) to encrypt all information between you and our website when entering your personal data
